AGENDA ITEMS:

Approve/Deny Tuscany Estates Phase 5 lot 501 Subdivision Plan

Working with Jessica Stiner and just wanted the board to know what he plans on doing. Jessica advised needs full plan within a week to get a hearing planned and advertised
