The Union Township Board of Supervisors meeting was called to order by Chairperson, Heather Daerr at 8:04 am The pledge of allegiance was recited.

Board Members in attendance by roll call were Richard Lawson, Robert Dooley, and Heather Daerr.

Also, in attendance, Nicole Wright-Secretary/Treasurer, Jessica Stiner-Engineer and James Donahoe-Project Department. Jessica Stiner-Engineer, and James Harshman- entered the public meeting at 9:02 am.

Public Comment on Agenda items:

George Cheplic: (No Address Given) Mr. Cheplic expressed his opinion regarding the Engineering requirements for his Grading Permit application. Mr. Cheplic asked the Board for a waiver from needing an Engineered stamped plan for his Grading Permit application.

James Donahoe-Project Manager delivered a presentation to the Board of Supervisors regarding the quotes he solicited for the 2020 liability insurance coverage for Union Township. Mr. Donahoe had a comparison summary for the Board to review from Henderson Brothers- Philadelphia/MRM, B&W/ Insurance- Argonaut, and Huntington- Travelers Insurance. Mr. Donahoe reported Philadelphia/MRM has a special program for non-profit and local government. This program was not able to be sourced by the other two carriers. Henderson Brothers, the agency for Philadelphia/MRM provided the lowest quote and deductibles. Argonaut was the second lowest responsible quote. Travelers quote had the highest premium costs and deductibles.

Discussions ensued amongst the Board and Mr. Donahoe regarding policy coverage.

Motion to pick Philadelphia/MRM for Union Townships liability coverage carrier for 2020 in the amount of \$22,734.00 with the deductibles as shown on the 2020 insurance policy comparison summary pending Sweat Law Offices verifying the authenticity the Philadelphia MRM company with the alternate being Argonaut Insurance coming in second at the amount of \$26,419.00 as being the next lowest responsible bid.
