Mr. Sweat asked for the Manager and Engineer to be present at the hearing. Solicitor, Gary Sweat noted he was asked to research three legal questions for the Board. Question 1. Are Planning Commission members required to file a State Ethics Commission Statement of Financial Interest? Mr. Sweat responded stating in Townships where the Planning Commission is empowered to approve subdivisions they are required to file a Statement of Financial Interest. Union Townships subdivision/land development ordinance makes it a requirement of any application must first go to the Planning Commission for review. Mr. Sweat noted every subdivision that he has seen in Union Township since he has been solicitor has had a notation on the subdivision mylar that had been signed by the Planning Commission. Solicitor Sweat also stated it has been confirmed by PSATS Legal Counsel Planning Commission members are required to complete Statement of Financial Interest forms. Question 2. Is it improper for Kevin Daers to be appointed as an alternate to the Zoning Hearing Board because his wife, Heather Dacre is an elected Supervisor? Mr. Sweat stated there is no prohibition against Mr. Dacre being appointed. Question 3. If a person has a record are they permitted to be appointed to any offices? Mr. Sweat stated an elector is someone who has even been convicted that is not in prison is eligible to vote. Mr. Sweat noted someone who has served ten years in prison convicted on a felony count, once they are released from prison they are eligible to vote, therefore they are considered an elector. The only requirement for appointing individuals to committees, commission or board is that they be an elector of the Township. Mr. Sweat noted he supplied the Board of Supervisors with a memo regarding question #3 in 2016. He stated if any Supervisor would like to see that memo he can provide it to them. Manager, Robert Balogh asked Mr. Sweat if multiple Supervisors can attend an upcoming Planning Commission meeting and it not be an issue related to a quorum? Mr. Sweat stated if the Supervisors do not make a decision or deliberate there is no problem. He stated that is not a Sunshine Law issue.

Supervisor, Heather Daerr stated Engineer, James Harshman was not present and once he arrives Mr. Harshman can deliver his report.

Manager, Robert Balogh reported to the Board of Supervisors he is scheduled to attend the Finleyville Borough Council Meeting on May 2, 2018 to discuss their request of the partial payment of the Finleyville VFD workmen's compensation insurance premium. Mr. Balogh noted he will comment further on this as it is presented as an agenda item. Moving forward, Mr. Balogh stated the meeting room public address system has been installed. Next, Mr. Balogh stated an additional fire safe is ordered for what post bound minutes that are in his possession. Moving forward, Mr. Balogh has reviewed the list of repository parcels.
