Solicitor, Gary Sweat first updated the Board of Supervisors on a recent letter he had received from the attorney for the DiLiscia's regarding the Declaration of Taking on property located on Coal Bluff Road. The DiLiscia's attorney counter offered Mr. Sweats original offer. The DiLiscia's are asking for

\$2,000.00 for the condemnation of their property. Next, Mr. Sweat informed the Board of Supervisors he has had conversation with Solicitor. Tim Bergran for the Ringgold School District. Mr. Sweat noted the Solicitor for the Ringgold School District is interested in talks regarding a tax abatement, LURTA program involving properties the Township would like to see developed. Mr. Sweat noted Solicitor Bergran believes the majority of the School Board would be open to discussions. Solicitor Bergran would like a general idea of the areas in Union Township that would be earmarked for development and a summary of how the program would work. Discussions regarding areas of development, a revenue allocation program, and act 537 plans ensued between the Board, Solicitor and Engineer.

Engineer, James Harshman noted he had a lot of updates for the Board. First, a Grading Permit Application has been received for the Caton Well site. It is under review. Mr. Harshman reported to Mr. Lawson the application does include Geotech information that he was looking for. Also, EQT is in the process of working on the preliminary upgrade plans for Pleasant View and Coal Bluff. Next, Mr. Harshman reported he has given Solicitor Sweat everything that Harshman CE Group had on the bond information for Tuscany Estates. Moving forward, Mr. Harshman noted the 2018 paving project is complete except for a few punch list items related to restoration, drainage and paving issues. Next, Mr. Harshman reported the McChain emergency slide repair work is complete. Mr. Harshman noted to the Board the CSX Railroad Street issue is something that was in Rob Balogh's hands, that is something that needs to be looked at. Moving on Mr. Harshman noted a couple of the Engineers and Pete were reviewing the Gilmore project. There are a few minor changes they would like to make to the project. Mr. Harshman will be sending in an amended application in for the specific scope of work and for approval before the job goes out for bid. Next, a land development application has been received for the Giant Eagle alternate access route. They are in review and Mr. Harshman expects them to be before the Planning Department at their next meeting. Mr. Harshman reported on the topic of the bridge replacement project that has been postponed until the spring. Moving forward in his report Mr. Harshman noted he had spoken to Carrie Fox. He stated the remediated Eframa chrome shop site maybe highlighted and showcased at the state level. Lastly, Mr. Harshman stated he had invited representatives from Apex to the meeting to share some information.
