Attorney, Wichael Cruny noted to the Board of Supervisors he would reserve the right to speak about agenda items as they were addressed.

Engineer, James Harshman updated the Board of Supervisors on the site meeting he had at the Finleyville Airport. Mr. Harshman stated his site meeting occurred on a rainy day. He noted there were recent concerns about some underdrains that were put in place during the repaving of the Airport runway. He

noted he was there observed them installed during in climate weather, he was happy to report there was no discharge of Stormwater coming from the underdrains. Moving forward, Mr. Harshman stated he also had conversations with Airport representatives about adding a few small detention ponds. He nated the Airport questioned construction specifications, Mr. Harshman stated he would be able to tell them what to build. Mr. Harshman stated he would be willing to donate a design if the Airport has volunteer efforts to implement the detention ponds. He would like to continue dialogue with Airport representatives at no cost. Mr. Harshman would also like to look at the implementing a Storm water management plan and the possibility of getting credits towards our MS4. Next, Mr. Harshman reported Mr. D'Amico is still following through on Code Enforcement action on the Airport pond, as well as the pond at Giant Eagle. Tuscany and The Shire, Next, Mr. Harshman reported APEX has volunteered to do the initial mowing and clearing of the Tuscany Estates pond and withhold billing the Township until the determination can he made where the funds would be coming from to pay for the invoice. Discussions ensued amongst the Board of Supervisors with the decision to table any offers from APEX until the escrow and bond situation is figured out. Moving forward, Mr. Harshman stated he received an email from Justin Stewart, the Geotech Engineer for the Tomko worksite. Mr. Harshman summarized Mr. Stewarts email stating there was concerns regarding Mr. Tomko following the Geolech Engineers recommendations. Mr. Stewart recommended Mr. Tomko stop all filling operations until they have a meeting to ensure the proper filling procedures are being followed. Mr. Harshman noted when he was at the Airport, he observed a fill area on Mr. Tomko's worksite where he noticed the proper equipment was not being used, instead of a sheepsfoot roller, they were using a regular drum roller. He noted there were also very large boulders rolled over the hillside not benched or keyed in. Mr. Harshman stated he forwarded that concern along with photographs to Mr. Stewart for him to follow up on. Mr. Harshman recommended the Zoning/ Code Enforcement Officer issue a notification letter to cease grading at the worksite until Mr. Stewart has a meeting with Mr. Tomko is up to speed with the Geotechnical recommendations. Mr. Harshman noted today he received compaction reports from October. Lastly, Mr. Harshman updated the Supervisors his office is still working thorough the final design development for the Overlook Sewerage project. He stated he would like to hust an informational workshop for the beginning of 2019.
