Asked the entire board if any board member has requested to view any bank accounts from January through current and been denied. No one said yes. Daerr asked if a Supervisor has asked any staff to view the accounts and denied them. The staff said no. Daerr stated she feels Esken's resignation is a great loss to the community.

Supervisor Dupree asked the Treasurer and Assistant Treasurer if there have been any requests by any Supervisor to be added to the bank accounts. Lawson said they had been talking about it for months. Dupree asked if there is any more hold up on this process. The staff indicated that there currently is not.

Stated that the proposal she received from First Response Medical Services is for an ALS service, not a BLS service.
