### 3. PUBLIC COMMENT (AGENDA ITEMS & MATTERS OF PUBLIC CONCERN):

#### **6. TOWNSHIP REPORTS:**

- A. Engineer Report. A verbal report was given by the Township Engineer. TJ Stephens advised the Board concerning various Township projects including sewage and road issues.
- B. Supervisor Reports. Michalle Dupree advised the public concerning a road issue near a Township Road. The Township Engineer and a member of the Roadcrew will review the road issue. Michalle Dupree also advised the public that the Township was missing a laptop computer and that the same was being utilized. The matter was reported to the Monongahela City Police Department.
  - Stephen Parish spoke about receiving authorization from PennDOT to install Jake Brake Signs on Finleyville-Elrama Road.

- C. A motion was made by Charles Wilson seconded by Stephen Parish to approve the resignation of Judith Taylor as Interim Treasurer for Union Township with regret. VOTE: ALL IN FAVOR. Motion Carried.
- D. A motion was made by Linda Evans-Boren second by Larry Sphar to approve Resolution for a Public Participation Policy with 4 minutes. VOTE: ALL IN FAVOR. Motion Carried.
- E. A motion was made by Michalle Dupree seconded by Charles Wilson to approve the Scarmazzi Homes Phase II Highland Village Development based upon the recommendation of the Township Engineer with the Township to assume no responsibility for the stormwater and the storm sewer Easement dated 10-31-2022 by and between Van Vhooris and Scarmazzi/Highland. VOTE: ALL IN FAVOR. Motion Carried.
- F. A motion was made by Linda Evans-Boren seconded by Michalle Dupree to approve the use of the Union Township meeting room one (1) day a month in order to assist State Representative Andrew Kuzma to better assist the Township residents. VOTE: ALL IN FAVOR. Motion Carried.

G. A motion was made by Charles Wilson seconded by Linda Evans-Boren to reaffirm the emergency purchase of an electrical harness for the high lift for the sum of \$2,854.35 from Murphy Tractor. VOTE: ALL IN FAVOR. Motion Carried.

- H. A motion was made by Linda Evans-Boren seconded by Stephen Parish to approve Ordinance 1 of 2023 entitled Union Township EMT/Firefighter Active Volunteer Tax Credit Ordinance of 2023. VOTE: ALL IN FAVOR. Motion Carried.
- I. A motion was made by Linda Evans- Boren seconded by Charles Wilson to approve Ordinance 2 of 2023 entitled Union Township Planning Commission Ordinance of 2023. VOTE: ALL IN FAVOR. Motion Carried.
- J. A motion was made by Michalle Dupree seconded by Stephen Parish to approve the resignation of Karen Stroop as Interim Receptionist with regret. VOTE: ALL IN FAVOR. Motion Carried.
- K. A motion was made by Linda Evans-Boren second by Stephen Parish to approve escrow accounts related to Verizon's use (Road Bore) of various Township roads. VOTE: ALL IN FAVOR. Motion Carried.

## 8. <u>DISCUSSION ITEMS.</u>

- A. Overlook sewage and the problems with the billing of owners/tenants. The Board of Supervisors advised the public of the issues concerning the prior billing of owners/tenants. The Township intends to correct the problem and contact South Park Township regarding potential billing of the same.
- B. Elrama Park Phase I grant closeout and discussion regarding Phase II concerning playground equipment. The Township intends to pursue the closeout of the grant and to purchase playground equipment in the future.
- C. Trax Road guiderail repair/replacement.

A Motion was made by Charles Wilson seconded by Larry Sphar to add to the agenda consideration of a proposal by Interstate Enterprises Inc. to remove damaged guiderail and replace the same. VOTE: ALL IN FAVOR. Motion Carried.

A Motion was made by Charles Wilson seconded by Linda Evans-Boren to accept a proposal from Interstate Enterprises Inc. dated February 17, 2023, in the amount of \$5,900.00 contingent upon Interstate Enterprises Inc. providing the appropriate insurance and the appropriate bond to the Township. VOTE: ALL IN FAVOR. Motion Carried.

D. Snee Road bridge removal. Discussion between the Supervisors and direction was given to the Solicitor to contact Washington County concerning the removal process.

E. Training for Township Treasurer/Assistant Secretary and Township Secretary/Assistant Treasurer. The Board discussed and directed the administration to seek training from PSATS and to pursue the mentor program with DCED.
