Wilson to terminate the temporary occupancy permit agreement for 123 Houston Run Road subject to the following conditions: (1) The \$1500.00 to cover potential Township enforcement costs is returned to the Owners. (2) The \$19,090.00 for corrective action is to be returned to the owner minus any escrow for a holding tank agreement, application fee and any additional administrative costs.

E. A motion was made by S. Parish and seconded by C. Wilson to approve a resolution to apply for a Department of Community and Economic Development (DCED) Block Grant.

- G. A motion was made by S. Parish and seconded by C. Wilson to hire Pete Guido for Township escrow project at \$18.00 / hour for 45 hours with no benefits.

- A. The Draft Deed of Dedication for Hidden Hollow Road TJ Stephens reported that he has some concerns regarding the Township taking over this road and will be following up on them. Concerns include not being able to add this to the Liquid Fuels inventory at this time and the need for information regarding the stormwater management plan.
- B. New West Elizabeth Sewage Authority (WESA) price structure for Elrama Sewage collection It may be prudent to review the existing contract with West Elizabeth going forward.
- C. Emergency Roof Repair Yohe Roofing, Inc. was called because of a roof leak above the copier room. They cleared some clogged areas, assessed the roof, and will send a quote to make the

necessary repairs and provide us with a quote for additional work, if necessary.

#### D. Stanley Door quote
