- Leroy G. Harkins 4586 Finleyville-Elrama Road, Finleyville, PA 15332: Believes there is a lack of communication between the Elrama Fire Company and the Township, and that the ISO information was not sent to the Fire Company.

Stated that she did not speak to Mr. Tyler Olsen of ISO while she was the Board Chair and will look into why he said she did.
